



MARKETPLACE VENDOR CONTRACT

SOUTH ATLANTIC SHRINE ASSOCIATION FALL FESTIVAL OF SHRINERS 2022:

MYRTLE BEACH, SOUTH CAROLINA

The marketplace in conjunction with the meeting of the South Atlantic Shrine Association Fall Festival of Shriners of 2022, shall be held in the Double Tree Resort by Hilton, Myrtle Beach, South Carolina. Booths reserved and paid for through this contract will be available for exhibitor set-up on Wednesday, September 14, 2022 from 9:00 AM to 5:00 PM and exhibitor tear down Saturday, September 17, 2022 from 3:00 PM to 6:00 PM. Hours for public display commence on Thursday, September 15, 2022 from 9:00 AM to 6:00 PM, Friday, September 16, 2022 from 9:00 AM to 6:00 PM and Saturday, September 17, 2022 from 9:00 AM to 3:00 PM. Late departures will be at the Exhibitors expense as determined by the Show Contractor, Convention Makers 4501 Hwy 544, Myrtle Beach, SC 29588 (843) 650-6300, John Dosemagen.

BUSINESS AREA AND ACTIVITIES: The exhibitor agrees to conduct business only during the specified business hours and to restrict activity to their booth

DESCRIPTION OF BOOTH SPACE: Each booth shall be a standard 10' x 10' space with an 8—foot high back wall and a 3—foot high sidewall. Back wall and sidewalls may not be moved without permission from the Marketplace Chairman. Each booth shall be furnished with an 8' skirted table, 2 chairs, 1 wastebasket and 1 sign with company name. Additional equipment required by the Exhibitor shall be rented from the Show Contractor at the Exhibitors expense. Electrical service shall be at the Exhibitors expense through the Double Tree Resort by Hilton. Each exhibitor should contact Missy Durham at (843) 315-7196 by September 7, 2022, to arrange for electricity.

FEES. TERMS OF PAYMENT AND RESERVATION OF BOOTHS: Rental Fees are as follows:

1. All corner booths are priced at \$400.00 each
2. All interior booths are priced at \$350.00 each
3. A discount of \$50.00 each is offered if adjoining booths are rented. Example: One corner booth (\$400.00) and the adjacent interior booth (\$350.00) minus the discount (\$50.00) would rent at the discounted price of \$700.00.
4. No discount is offered for corner booths. Cost for two booths would be \$800.00.

PAYMENT in full is due with signed contract. All prices are quoted in United States Dollars. US Bank Checks or US Money Order should be made payable to SASA 2022. Exhibitors are requested to stipulate their preferences for booth space by booth number including first and second choices. Every effort will be made to comply with the Exhibitor's highest priority preference but will be based on a first come basis with full payment.

SUBLETTING OE SPACE: No Exhibitor may assign, sublet, or apportion the whole or any part of the allocated space, nor exhibit therein any goods other than those manufactured or handled by the Exhibitor in the regular course of business, nor permit any representative of any other firm to solicit business, take orders, or sublet the space.

LIABILITY: The Exhibitor understands and expressly agrees the South Atlantic Shrine Association, Shriners International, Double Tree Resort by Hilton and their directors, officers, members, agents and employees will not be responsible for any of, or damage to, goods, services, or property of Exhibitor or Exhibitor's employees, Exhibitor on signing this contract expressly releases the above mentioned and agrees to indemnify them against all claims. The Exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, defend, and save the South Atlantic Shrine Association, Shriners International or Doubletree Resorts by Hilton and their directors, officers, members, agents and employees harmless against all claims, losses and damages to persons or property, government charges or fines, and attorney fees arising out of or caused by Exhibitors acts of omission and/or commission of any nature.

SALES TAXES: Information pertaining to Exhibitors responsibility to meet South Carolina State and City and County sales tax requirements may be obtained by contacting the State of South Carolina, County of Horry and City of Myrtle Beach. The Exhibitor shall be solely responsible for payment of all tax liabilities to the proper authority. MAXIMUM EXHIBIT SIZE: All exhibits shall conform to the assigned booth space and shall not restrict visual or physical access to adjacent Exhibitors or infringe upon adjacent access aisle ways.

RELOCATION OF EXHIBITS: South Atlantic Shrine Association reserves the right to alter location of exhibits or of displays as shown on the official floor plan in their sole discretion if deemed advisable and to be in the best interests of South Atlantic Shrine Association.

SHOW CONTRACTOR: Convention Makers, Inc., John Dosemagen (843) 650-6300 will provide furnishings as listed in the "Description of Booth." Additional services, furnishings and labor will be available through Convention Makers at additional costs.

SERVING FOOD AND DRINK: The serving or sale of any food or beverage in the exhibit area is forbidden without the written permission of the Marketplace Chair.

LICENSING: Should any of the items your company plans to sell at the Marketplace contain the words "Shriners Hospitals" or "Shriners Hospitals for Children" or the logo for Shriners Hospitals for Children or the picture of the "Editorial Without Words", it is necessary that a written Licensing Agreement be signed between your company and Shriners Hospitals for Children. AMENDMENTS OF CONTRACT RULES: Any questions not specifically covered by the preceding provisions shall be subject solely to the decision of the South Atlantic Shrine Association Marketplace.
